Please enter the site via Gedling Street, it is a pedestrian area, so please drive slowly with your hazard lights on.

EVENT TIME

10:00am - 4:00pm

SET UP TIME

8:00am - 9:15am

You must be onsite by 9:15am.

If you are not, you will not be allowed on site to set up.

All vehicles must be offsite by 9:30am.

PACK DOWN TIME

4:00pm - 5:30pm

Vehicles will be allowed onsite at 4:00pm or once stated by a member of Kordia Staff.

You must not pack down before 4:00pm.

POWER

We do not have any equipment for hire, and if you do not have commercial-grade gazebos
and weights, you may not be allowed to set up and will not be allowed to trade.

VEGAN POLICY

This is a 100% vegan and plant-based market.
All of your products must be 100% plant-based without the use of any animal products.
This includes honey, wool and all other products that are not 100% vegan.



EVENT CANCELLATION POLICY

If the event is cancelled by Kordia, we will aim to alert our traders as soon as possible. If the event is cancelled, we will provide an alternative date for the event where possible. If we cannot provide an alternative date, we will move your fee to the next market that you are booked in for.

Please note that we will not cancel a market if it is raining, so please be prepared for all weather conditions.

REFUND POLICY
